Last year,ORC-2023 was held from 14th to 16th November,2023 at Sambalpur University. ORC provides an opportunity to the faculty members and Research Scholars to showcase their research output through poster presentation.

This year, Fakir Mohan University has kindly agreed to host the "Odisha Research Conclave-2024" from December 26th to 28th, 2024. 
